## 10. Review and discuss Letter from West Virginia Legislative

The letter from the West Virginia Legislative Auditor's Office informs county commissions about key changes to the audit process for Volunteer Fire Departments (VFDs) following the passage of Senate Bill 500 in 2025. Effective July 6, 2025, sole authority for audits and financial examinations of VFDs has shifted from the State Auditor to the Legislative Auditor, encompassing all accounts and financial activities rather than just the state account. The State Auditor will complete any ongoing audits, after which the Legislative Auditor will begin full audits starting January 1, 2026, for 2025 transactions. However, the State Auditor remains the contact for WV Checkbook matters. The office plans to communicate directly with VFDs, providing copies to commissions, and outlines changes such as requiring annual submission of bank statements and check images by February 1, establishing a single resource for auditrelated questions, eliminating overlapping audits, expanding audit scope to all finances, enhancing procedures, and developing online training resources. Notably, audit findings affecting state funding distributions will still only apply to the state account. The transfer also has implications for county commissions, including requests for documentation on any parameters or restrictions for VFD fund usage (e.g., levy calls, purchasing procedures, memorandums of understanding) from 2023 to 2025, as well as details on financial assistance methods like centralized purchasing or grant agreements. The Legislative Auditor will notify commissions when audits of local VFDs begin, request supporting information, and share completed audit results annually. This aims to ensure transparency and support during the transition.
